
ORDER

1. THIS COURT ORDERS that the defendants be restrained from the use or exploitation of the name "Randy Bauchman" or any likeness thereof for any touring or promotional purpose whatsoever until the trial of this action or further order of the Court.

3. THIS COURT ORDERS that costs be reserved to the trial Judge.




